


FINAL PLAT GLACIER BUSINESS PARK THIRD FILING

RANGE 68 WEST OF THE 6TH P.M., COUNTY OF WELD, STATE OF COLORADO.




VICINITY MAP

A PARCEL OF LAND SITUATED IN THE SOUTH HALF OF THE NORTHEAST QUARTER OF SECTION 3, TOWNSHIP 1 NORTH, RANGE 68 WEST OF THE 6TH PRINCIPAL MERIDIAN, COUNTY OF WELD, STATE OF COLORADO, BEING MORE PARTICULARLY DESCRIBED FOLLOWS:

BEGINNING AT A POINT ON THE NORTH LINE OF SAID SOUTH HALF OF THE NORTHEAST QUARTER OF SAID SECTION 3, WHENCE THE NORTHEAST CORNER OF SAID SOUTH HALF BEARS SOUTH 89°57'13" EAST 904.70 FEET, SAID POINT ALSO BEING ON THE SOUTH BOUNDARY LINE OF GLACIER BUSINESS PARK, AMENDED FIRST FILING AS RECORDED AT RECEPTION NO. 2712809 OF WELD COUNTY RECORDS; THENCE ALONG SAID NORTH LINE OF THE SOUTH HALF OF THE NORTHEAST QUARTER OF SAID SECTION 3, SOUTH 89°57'13" EAST 654.70 FEET TO THE SOUTHWEST CORNER OF THE SAID PLAT OF GLACIER BUSINESS PARK, AMENDED FIRST FILING; THENCE SOUTH 00°10'35" WEST 1344.64 FEET TO A POINT IN THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 3 WHENCE THE EAST QUARTER CORNER OF SAID SECTION 3 BEARS NORTH 89°56'18" EAST 250.01 FEET; THENCE ALONG SAID SOUTH LINE SOUTH 89°56'18" WEST 651.65' TO THE SOUTHWEST CORNER OF THE PLAT OF GLACIER BUSINESS PARK, AMENDED SECOND FILING AS RECORDED AT RECEPTION NO. 2712809 OF WELD COUNTY RECORDS WHENCE THE CENTER QUARTER CORNER OF SAID SECTION 3 BEARS SOUTH 89°56'18" WEST 1757.64 FEET; THENCE ALONG THE EAST LINE OF SAID GLACIER BUSINESS PARK, AMENDED SECOND FILING, NORTH 00°02'47" EAST 1345.87 FEET TO THE POINT OF BEGINNING, CONTAINING 20.172 ACRES MORE OR LESS.
